## **Daily COVID-19 Update for Montgomery County**

Status Update from the Office of Homeland Security and Emergency Management

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, can sadly confirm two additional deaths related to COVID-19.


- A man in his 60s, from Conroe, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19.
- A man in his 70s, from Spring, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19.

We offer our condolences to both families at this difficult time.

## We can also confirm:

- TOTAL cases of COVID-19 increased by 207 to 8,122 since Friday's report.
  - We are continuing to process cases that were reported to The Department of State Health Services (DSHS) directly by healthcare providers and entered into the National Electronic Disease Surveillance System (NEDSS), run by the CDC. Out of the 207 new total cases since Friday's report, 171 (from the NEDSS system) tested positive prior to August 5th. - ACTIVE cases of COVID-19 increased by 99 to 1,479 since Friday's report.
- 47 residents are known to be in the hospital, as a result of contact investigations. Contact investigations have not been initiated on all reported cases.
- 5,653 people have clinically recovered.




