## **Daily COVID-19 Update for Montgomery County**

*Status Update from the Office of Homeland Security and Emergency Management*

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, is saddened to confirm four additional deaths related to COVID-19, bringing the total to 129.

- A man in his 50s, from Spring, died in the hospital. There were no co-morbidities noted in the medical record.
- A woman in her 90s, from The Woodlands, died in hospice care. She had co-morbidities in addition to testing positive for COVID-19.
- A man in his 70s, from Conroe, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19.

We can also confirm:

- TOTAL cases of COVID-19 increased by 120 to 9,586 since yesterday's (9/9) report.
  - We are continuing to process cases that were reported to The Department of State Health Services (DSHS) directly by healthcare providers and entered into the National Electronic Disease Surveillance System (NEDSS), run by the CDC. Out of the 120 new cases today, 59 were tested prior to 7/31.
- ACTIVE cases of COVID-19 increased by 46 to 1,258 since yesterday's (9/9) report.
- 24 residents are known to be in the hospital, as a result of contact investigations. Contact investigations have not been initiated on all reported cases.
- 6,601 people have clinically recovered.

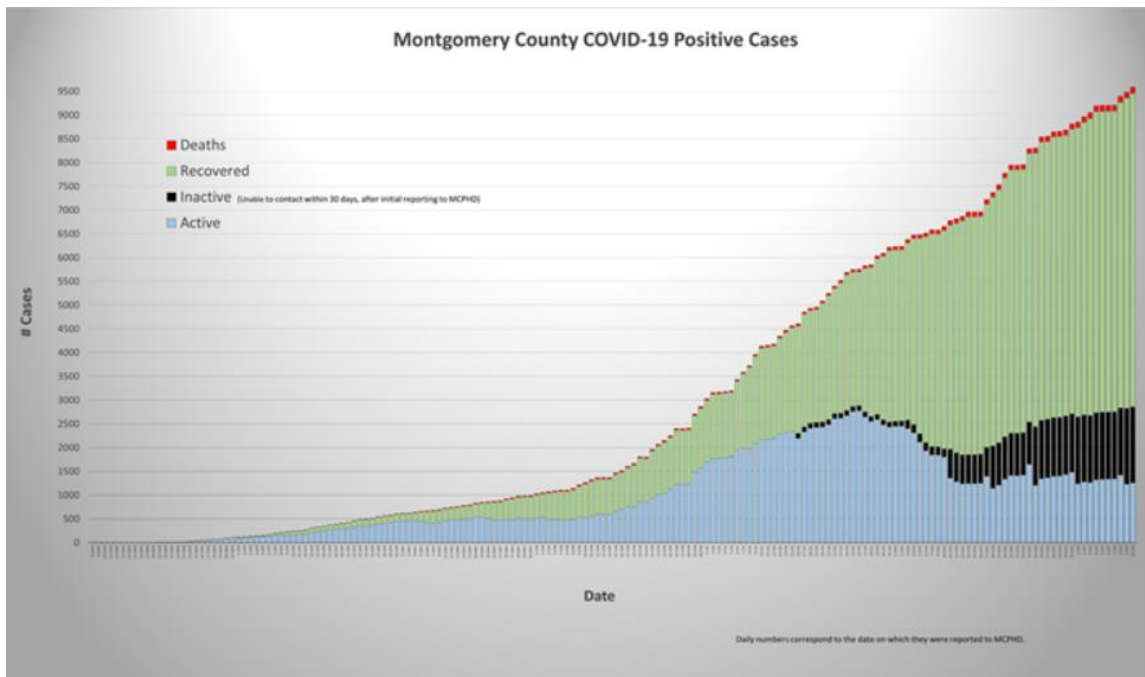

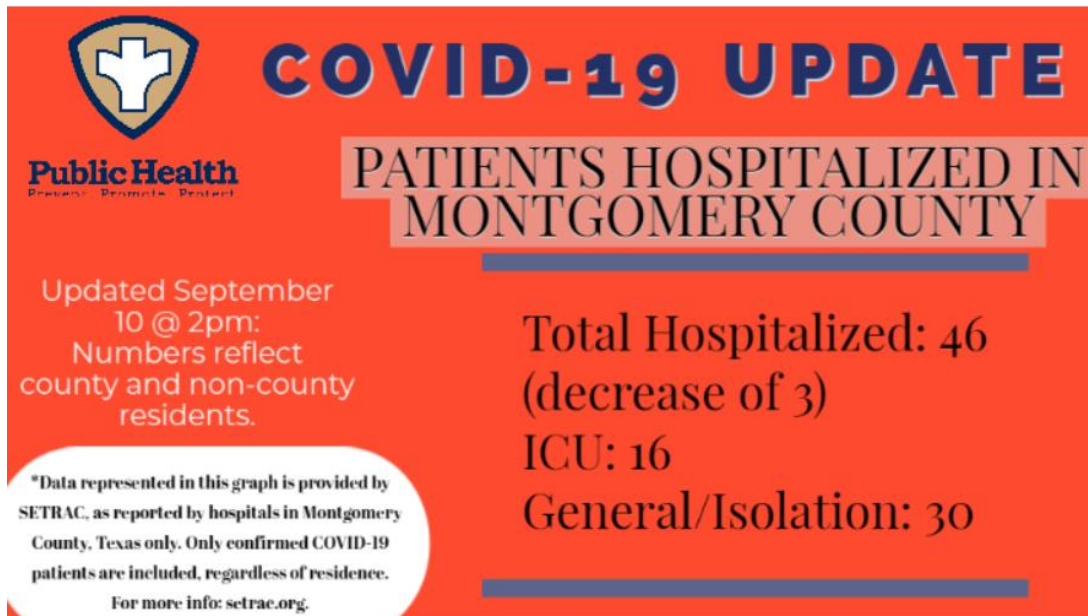
