Daily COVID-19 Update for Montgomery County *Status Update from the Office of Homeland Security and Emergency Management*

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, is saddened to confirm an additional death related to COVID-19.

A woman in her 50s, from Conroe, died in the hospital. She had co-morbidities in addition to testing positive for COVID-19.

We can also confirm:

- TOTAL cases of COVID-19 increased by 95 to 10,666 since Friday's (9/18) report. All cases were tested in the month of September.
- ACTIVE cases of COVID-19 increased by 24 to 1,669 since Friday's (9/18) report.
- 25 residents are known to be in the hospital, as a result of contact investigations. Contact investigations have not been initiated on all reported cases.
- 7,153 people have clinically recovered.


