Daily COVID-19 Update for Montgomery County

Status Update from the Office of Homeland Security and Emergency Management

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, is saddened to confirm an additional death related to COVID-19.

A woman in her 80s, from Spring, died in the hospital. She had co-morbidities in addition to testing positive for COVID-19.

We can also confirm:

- TOTAL cases of COVID-19 increased by 45 to 10,711 since yesterday's (9/21) report. All cases were tested in the month of September.
- ACTIVE cases of COVID-19 decreased by 100 to 1,569 since yesterday's (9/21) report. On Tuesdays, we factor in additional inactive cases, which are cases we have been unable to contact for more than 30 days. Today, an additional 144 inactive cases noted.
- 23 residents are known to be in the hospital, as a result of contact investigations. Contact investigations have not been initiated on all reported cases.
- 7,153 people have clinically recovered.


