Daily COVID-19 Update for Montgomery County

Status Update from the Office of Homeland Security and Emergency Management

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, can sadly confirm an additional death related to COVID-19.

A man in his 60s, from Magnolia, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19.

We can also confirm:

- TOTAL cases of COVID-19 increased by 167 to 12,022 since yesterday's (10/7) report.
 - We have continued to process cases that were reported to The Department of State Health Services (DSHS) directly by healthcare providers and entered into the National Electronic Disease Surveillance System (NEDSS). Out of the 167 new cases today, 81 were tested prior to 9/24.
- ACTIVE cases of COVID-19 increased by 65 to 1,738 since yesterday's (10/7) report.
- 19 residents are known, as a result of contact investigations, to be in the hospital. Contact investigations have not been initiated on all reported cases.
- 7,951 people have clinically recovered.




