Daily COVID-19 Update for Montgomery County

Status Update from the Office of Homeland Security and Emergency Management

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, can sadly confirm two additional deaths related to COVID-19.

- A woman in her 60s, from Conroe, died in the hospital. She had co-morbidities in addition to testing positive for COVID-19.
- A man in his 70s, from Magnolia, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19.

We can also confirm:

- TOTAL cases of COVID-19 increased by 56 to 14,280 since yesterday's (11/4) report. All cases were tested in the past 7 days.
- ACTIVE cases of COVID-19 decreased by 42 to 2,008 since yesterday's (11/4) report.
- 36 residents are known, as a result of contact investigations, to be in the hospital. Contact investigations have not been initiated on all reported cases.
- 9,256 people have clinically recovered.

Please note, the next update will be Monday, November 9th due to COVID-19 database maintenance.


