



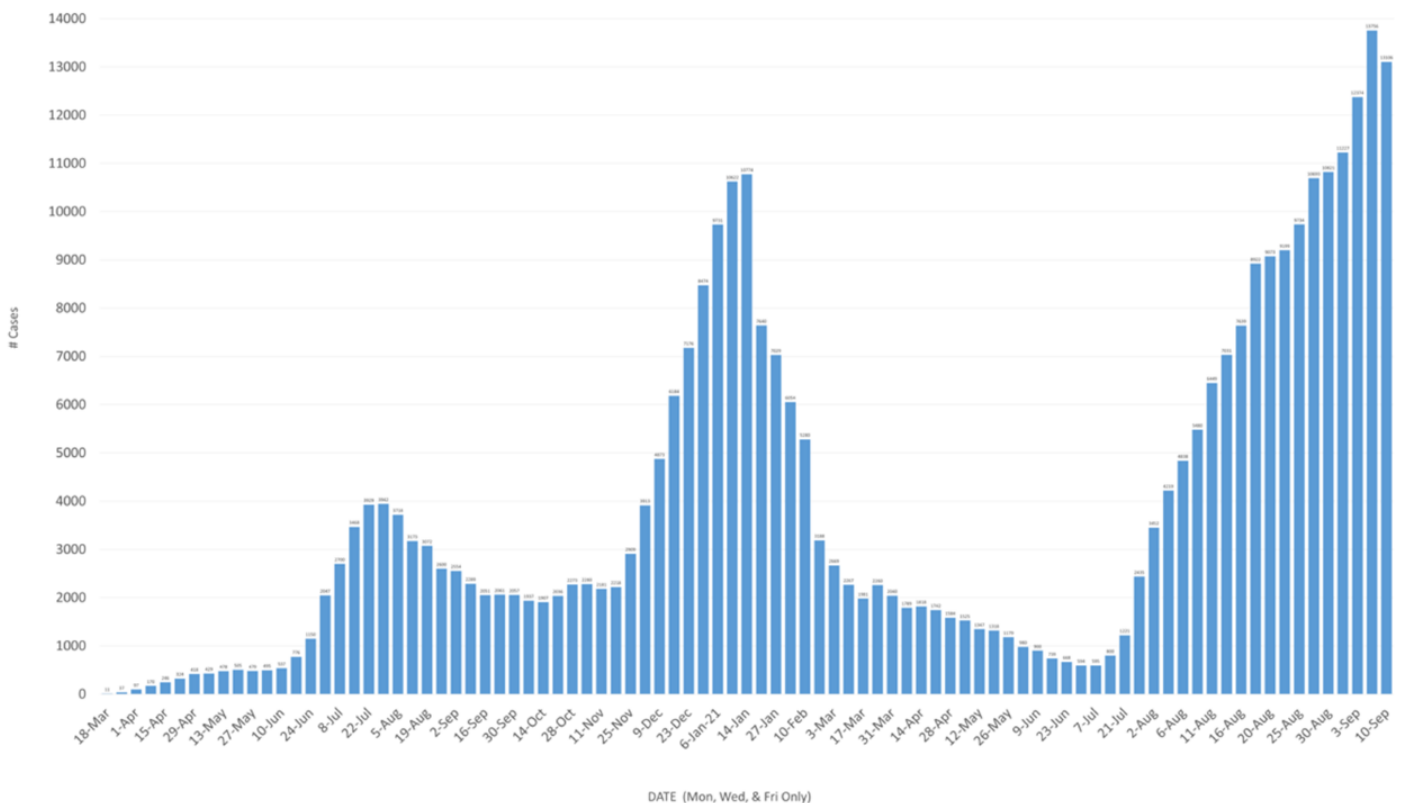

COVID-19 Update for Montgomery County

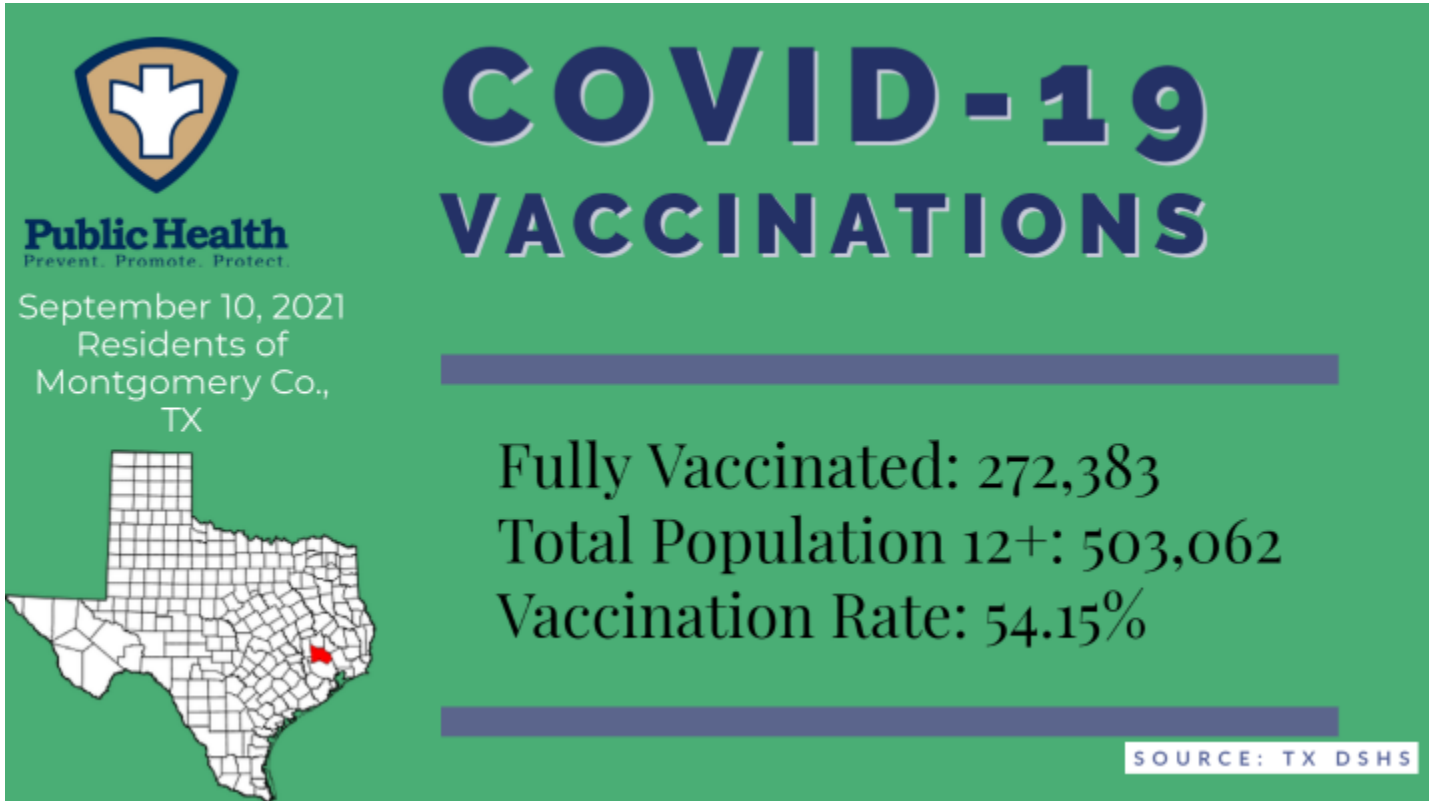
Status Update from the Office of Homeland Security and Emergency Management

MONTGOMERY COUNTY – Montgomery County Public Health District, in conjunction with the Montgomery County Office of Homeland Security and Emergency Management, can confirm we remain at record high levels of COVID-19 active cases in Montgomery County.

Active Cases at a Glance



Have you been vaccinated for COVID-19? We strongly recommend it. Even if you contract COVID-19 after vaccination, the chances of severe illness, hospitalization and death are low. Today, we can also confirm four additional deaths related to COVID-19.

- A man in his 40s, from Porter, died in the hospital. There were no co-morbidities noted in his medical records. He was not vaccinated.
- A man in his 50s, from Conroe, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19. He was not vaccinated.
- A woman in her 60s, from Conroe, died in the hospital. She had co-morbidities in addition to testing positive for COVID-19. She was not vaccinated.
- A man in his 70s, from Conroe, died in the hospital. He had co-morbidities in addition to testing positive for COVID-19. He was not vaccinated.

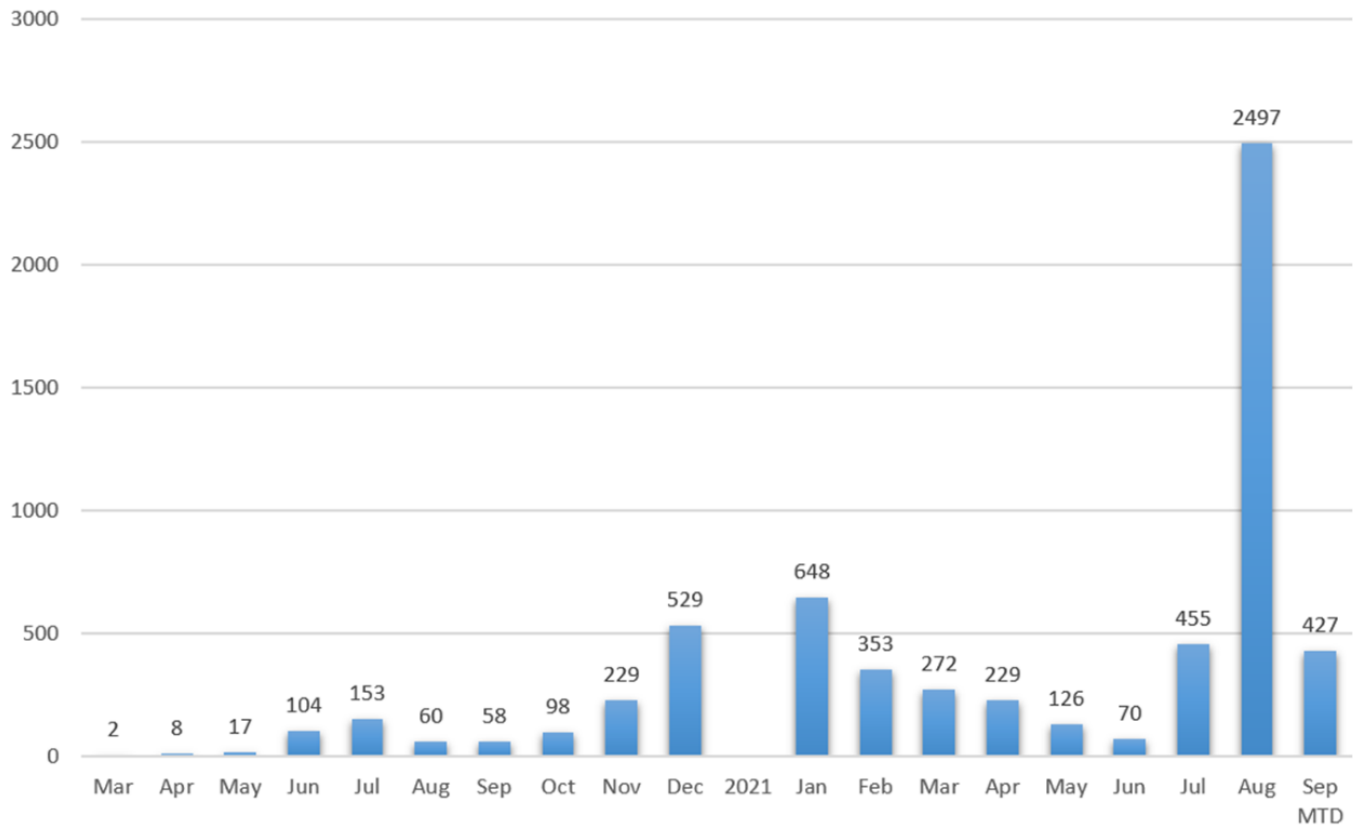
We can also confirm:

- TOTAL cases of COVID-19 increased by 916 to 79,450 since Wednesday's (9/8) report.
 - Of the 916 new cases, 158 are under the age of 12 and not eligible for vaccination.

- ACTIVE cases of COVID-19 decreased by 650 to 13,106 since Wednesday’s (9/8) report.
 - Today, we accounted for 1,557 additional inactive cases who we have been unable to contact for 30 days or more.
- 349 county residents are known, as a result of contact investigations, to be in the hospital. Contact investigations have not been initiated on all reported cases.
- 32,087 people have clinically recovered.

The Testing Positivity Rate for Montgomery County remains at 20%, down from 21% last Friday (9/3).

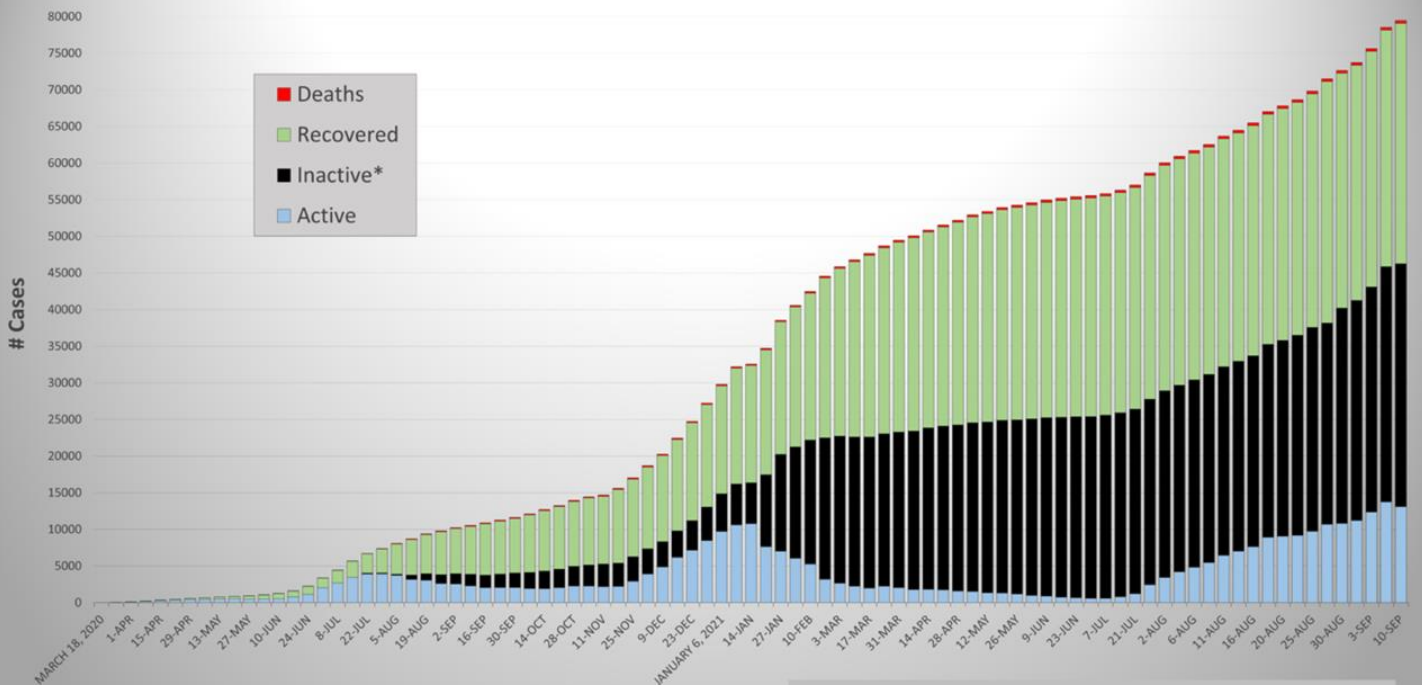
