Incorporation Election

- On August 13, 2021, The Woodlands Township Board called an Incorporation election.
- Two propositions will appear on the November 2, 2021 ballot.
- Wording for the propositions was developed by legal counsel and based on requirements in State Law, including the Township's enabling legislation.

Incorporation - Proposition A

- Proposition A creates the City of The Woodlands and sets its maximum initial tax rate.
- Residents of The Woodlands Township can vote “for” or “against” the proposition shown below:

THE WOODLANDS TOWNSHIP – PROPOSITION A
Authorizing the Type-A city incorporation of The Woodlands Township District and the adoption of an initial property tax rate of not more than \$0.2231 per one hundred dollars (\$100) valuation of taxable property

Incorporation – Proposition B

- Proposition B depends on Proposition A passing.
- Proposition B transfers the Township’s rights, responsibilities and authorities of the Township to the new City of The Woodlands, dissolving the Township.
- The Woodlands Township voters can vote “for” or “against” the propositions shown below:

THE WOODLANDS TOWNSHIP – PROPOSITION B

Upon incorporation of The Woodlands Township District into a Type-A General Law City to be called the City of The Woodlands, the transfer of the rights, powers, privileges, duties, purposes, functions, responsibilities, the authority to issue bonds, and the authority to impose taxes from The Woodlands Township District to the City of The Woodlands

Key Dates

- October 4, 2021 Last Day to Register to Vote
- October 18, 2021 First Day of Early Voting by Personal Appearance
- October 22, 2021 Last Day to Apply for Ballot by Mail (received, not postmarked)
- October 29, 2021 Last Day of Early Voting by Personal Appearance
- November 2, 2021 Election Day

Voter Information

Voting Eligibility

- To vote in The Woodlands Township election, you must be a registered voter in the county of your residence and a resident of The Woodlands Township.

 - Election Day will use consolidated precinct locations
- *Voters in the Village of Creekside Park*
